### President of the Professional/Medical Staff REPORT

#### PHYSICIAN BURNOUT

The well-being and health of our caregivers is of paramount importance to the delivery of excellent health care.

In the past few years research has shown that the physician burnout is on the rise.

Burnout is a long term stress reaction that includes emotional exhaustion and a sense of depersonalization and a lack of a sense of personal accomplishment.

Survey's by the AMA, Rand Corporation and many others show that the hours and demands of the work, the requirements to interact regularly with insurance companies, the increase clerical duties, the inefficient electronic medical records (EMR), loss of a sense of autonomy and difficulty in maintaining a work-life balance all contribute to the problem.

While the physicians argue with the importance of EMR they have not been properly streamlined. These EMR systems are not well designed for medical use and interfere with face to face doctor to patient experience. EMR systems are burdensome and have turned physicians into data entry clerks.

When physicians become discouraged and leave medicine the current doctor shortage is exacerbated and at a cost of \$250k to replace that physician never mind the discontinuity of care.

So what is to be done? Blow up the EMR? Not likely.

There are large institutions conducting research in the field. Most seem to believe the cure lies in healthy encounters and relationships among health-care workers, colleagues and patients. Workshops to promote compassionate mediation and communication have been found to reduce stress and burnout and enhance physician resilience.

We, at Providence have some psychological help already available and are in the process of expanding this program into a more proactive rather than reactive program in the hope of preventing some stress and burnout. As programs to maximize physician well-being are implemented, patients will also be able to feel more confident that they, too, are getting the best care available.

#### Physician Survey

Our sincerest thanks go out to all of you who took the time to complete the Physician Survey back in October/November. The results have finally been processed by the firm of Press Ganey and sent to us to review. Overall, the hospital did quite well in areas of physician engagement, alignment, and satisfaction, scoring above the national mean in all those areas. Departments scoring the highest included Emergency Department, Operating Room, and Radiology. Scheduling also scored much higher than the national mean. And despite the pains of adapting to the EPIC EMR, record keeping scored very high, with many positive comments in the narrative section of the survey. Only 16 of 50 questions scored below the national average.

Those of us in administration will be meeting with key medical staff members around some of the weaknesses found in the survey and look forward to hearing how we can improve. We will also present the survey results in more detail at the General Staff Meeting.

Again, thank you for your participation and ongoing support of our facility.

#### CARDIOVASCULAR CENTER OF EXCELLENCE \$35 MILLION

Our "Heart to Heart" Campaign for the Cardiovascular Center of Excellence over the next three years includes:

- \* Hybrid OR Suite for expansion of cardiac and endovascular surgical capabilities
- \* Cardiac catheterization laboratory upgrade and expansion that includes refurbishing and relocating Electrophysiology Suite with Stereotaxis, refurbishing and updating existing catheterization laboratory rooms, and bring additional catheterization laboratory room
- \* State-of-the-art monitoring and diagnostic screening equipment for improved cardiac monitoring throughout the hospital (emergency, critical care, and telemetry units, in addition to perioperative areas)


