Bargaining

Physicians continue to try to understand the changing landscape of healthcare. Hospitals and healthcare systems are already being reimbursed based on inpatient quality measures. This will soon carry over to the outpatient practice as the final rules for MACRA were recently released on Oct 14th, 2016. The impact of all these changes on our individual practices is difficult to predict but one can be confident that substantial resources will need to be invested to be successful.

I long for the days when I could spend more time with each patient, write whatever was meaningful in their note, and be done with the chart when I shook their hand goodbye. Nowadays I spend countless time making sure that I click on endless boxes trying to prove that I am giving quality care. PLCMMCT Receives 'A' Grade for Fall 2016 Patient Safety

The Leapfrog Group's Leapfrog Hospital Safety Grade assigned PLCMMCT an "A" letter grade for patient safety in its Fall 2016 report. The Leapfrog Hospital Safety Grade uses national performance measures from the Centers for Medicare & Medicaid Services (CMS), the Centers for Disease Control and Prevention (CDC), American Hospital Association's Annual Survey, the Agency for Healthcare Research and Quality (AHRQ) and the Leapfrog Hospital Survey to produce a single letter grade representing a hospital's overall performance in keeping patients safe from preventable harm and medical errors. The bi-annual grade reports are shared publically, helping patients make informed decisions regarding their health care options.

TORRANCE CELEBRATES 10 Year Anniversary of Robotics Program







PLCMMCT recognized the 10-year anniversary of the da Vinci robotic surgery system, honoring the physicians and operating room staff who work with the system on a regular basis. First used at Providence in 2006, the da Vinci system offers patients a less invasive alternative to traditional surgical procedures, resulting in shorter recovery times and less blood loss. Gerald Carven, one of the first patients to undergo a procedure using the Providence da Vinci system, shared his surgical success story with the celebration's attendees. Dr. Garrett Matsunaga, Gerald's surgeon, was a main proponent of the hospital acquiring the da Vinci, and spoke about the Robotics Program's many benefits.

Robotic technology serves a wide range of other functions at Providence. The MAKO systems are used to assist physicians performing partial knee replacement and hip replacement surgeries. The telemedicine program allows physicians to virtually meet with patients via robots. There are even germ-killing robots that help us sanitize patient rooms by emitting UV rays. These advances continuously enable us to better serve our patients, and we look forward to seeing what new capabilities robotic technology may provide in the future.

PROVIDENCE ANNOUNCES AFFILIATION
WITH HOUSE CLINIC

Providence Health & Services, Southern California has finalized its affiliation with the renowned House Clinic, a leader in ear and skull-based surgery that is recognized for pioneering research and training programs.

House Clinic, founded 60 years ago, will enhance the neuroscience specialty throughout Providence, one of the nation's largest Catholic not-for-profit health care systems. A new clinical program in neurotology, a subspecialty that includes surgery of the ear and skull base, as well as the medical treatment of hearing loss

and ear disease, will be added. It will involve nationally-recognized clinicians, a fellowship program and innovative clinical research.

This new affiliation will enable Providence clinicians to access House Clinic's clinical expertise, clinical trials and fellowship programs through collaboration and telehealth technology. The affiliation will help Providence meet the needs of the communities it serves across Southern California.

House Clinic will continue its historic relationship with St.Vincent Medical Center, part of the Verity Health System, and will maintain a location in downtown Los Angeles. Under the new agreement, plans call for one of the Providence Southern California medical centers to serve as the new hub, with satellite locations and hearing aid dispensary sites throughout the Greater Los Angeles Area, Orange County, Bakersfield, the West Coast and beyond.

Providence and House Clinic will partner in clinical research, education and community outreach. House also operates outreach

clinics in Hawaii, Palm Springs and Singapore.

House Clinic's research has resulted in these milestones:

- Founder in microscopic ear and skull-based surgery
- First cochlear implant system
- First digital hearing aid
- First auditory brainstem implant
- First functional hearing test
- Human cell lines for auditory research

House Clinic has grown to include 10 physicians – seven neurotologists, including an otolaryngic allergist; two neurosurgeons; and an otolaryngologist who is a specialist in dizziness and balance –and 19 audiologists.



Providence sought the affiliation to support its Neuroscience Clinical Institute development, expanding the specialties available to patients throughout the region and beyond.

As part of the affiliation, Providence will partner with House to continue their work with UCLA Health to support House Clinic's Neurotology fellowship and research program at UCLA and the newly renamed House Children's Hearing Center of UCLA with Providence.
