

# Xuquuqda iyo Masuuliyadaha Bukaanka

## Patient Rights and Responsibilities

### (Somali)

#### **BALANQAADKAYGA AAN KUU QAADAYNO, BUKAANKAYAGA:**

Providence St. Joseph Health and its affiliates, waxaan aaminsanahay in caafimaadku yahay xaq uu leeyahay aadanuhu. Qof kastaa wuxuu u qalma inuu ku noolaado nolosha ugu caafimaadka badan. Hadafkayagu wuxuu nagu baaqayaa inaan daryeelno dhamaan anagoo ixtiraamayna sharafta iyo kala duwanaanta qof kasta. Waanu ku soo dhawaynaynaa, marxalad kasta oo nolosha ah, waxaana naga go'an inaan bixino daryeel ku aqoonsanaya oo ku xaqiijinaya inaad tahay qof dhamaystiran. Waxaan ku dadaaleynaa inaan samayno deegaan soo dhaweyn, badqab iyo ixtiraam leh si aad ugu dabaaldegto waqtiyada ugu xurmada badan nolosha iyo inaan ku garab istaagno waqtiyada adag. Waxaad nagu kalsoonaan kartaa inaan ku dhagaysano, ku fahanno oo aan kula shaqeyno si aan u gaarno hadafyadaada caafimaad ahaaneed. In ka balaaran bogsashada iyo caafimaadka, waxaa naga go'an inaan tirtirno sinaan la'aanta caafimaadka, oo ay kamid tahay siinta qof kasta daryeel loo siman yahay oo loo heli karo si badqab leh, tayo sare leh, waxtarna leh. Takoorid ma jiri doonto, waxaad filan kartaa daryeel aan eexasho lahayn. Waxaan kaaga mahadcelineynaa inaad nagu aamintay daryeelkaaga - waa mas'uuliyad iyo sharaf aad noogu weyn.

#### **BUKAANKAYAGA AHAAN, WAXAAD LEEDAHAY XUQUUQDA SOO SOCOTA:**

##### **In lagu xushmeeyo, sharaf, iyo cadaalad**

Waxaad xaq u leedahay in aad hesho daryeel tixgalin, naxariis leh, asturan oo ixtiraam leh. Waxaa laguula dhaqmi doonaa si sharaf leh, sidaas darteedna ka maran dayac, ka faa'iidayasi, xadgudub, cagajugleyn, cunsuriyad, ama takoorid. Dhammaan bukaannadu waxay xaq u leeyihiin inay ka xoroobaan xadgudub jir ahaaneed ama maskax ahaaneed, iyo ciqaab jir ahaaneed. Providence St. Joseph Health and its affiliates waxay siin doontaa daryeel tayo sare leh, daryeel ay u dhan yihiin dhammaan dadka nasoo booqda. Waxaan kuu aragnaa inaad tahay qofka gaarka ah ee aad tahay, waxaan ku siin doonaa daryeelkaaga hab-dhaqan ahaan kugu haboon.

Waxaa naga go'an inaan meesha ka saarno sababaha dulmiga keena. Waxaan si ixtiraam iyo taxadar leh u daryeelnaa dhamaan shakhsiyaadka helaya adeegyada. Waxaan soo dhawaynaynaa dadka isir kasta leh, da'da kasta, caqiido kasta, qowmiyadaha, dhaqamada, wadan kasta kasoo jeeda, wadanka kasta dhalasha u dhasha, luqadaha iyo/ama heerka socdaalka, heerka dhaqaalaha, isha lacag bixinta daryeelka, diimaha, caadooyinka, dhaqamada, iyo abtirsiiinta. Waxaan sharafnaa oo aan ixtiraamnaa dhammaan lamaanaha guur, lamaane qoys ahaaneed, ama ururada rayidka ah, muuqaalka iyo cabbirka jirka, jinsiga, nooca galmada iyo aqoonsiga jinsiga ama muuqaalka. Waxaan soo dhaweyneynaa oo aan bixinaa daryeel u siman dhamaan naafanimada jir ahaaneed ama dhimir ahaaneed ama garaad haaneed, curyaanimo ama awooda hawl qabsi ahaaneed, xaaladaha caafimaad (oo ay ku jiraan xaaladaha HIV/AIDS, kansarka, hidde-sidaha, isticmaalka mukhaadaraadka iyo cudurada cuntada), taariikhda caafimaadka qoyska, heerka halyeeyga ama militariga, iyo wax kasta sifada uu ilaaliyo federaalka, gobolka, ama sharciga deegaanka.

##### **Deegan Badqab leh**

Waxaad xaq u leedahay in aad daryeel ku hesho goob badqab leh, si aad u hesho adeegyada ilaalinta iyo u doodista, iyo in aad xor ka noqoto xadgudubka iyo dhibaataaynta.

##### **Si aad xor uga noqoto xanibaad ama takoorid**

Waxaad xaq u leedahay inaad ka xorowdo caqabadaha takoorid. U isticmaalka caqabadaha ama takoorida sababaha soo socda waa mamnuuc: iyadoo lagu saleynayo isirka bukaanka, midabka,

aqoonsanayo sharciyada ka hortagga takoorka), ama jinsiga (ay ku jiraan uurka, nooca galmada, aqoonsiga jinsiga, iyo muujinta), iyo dhammaan qaybaha kale ee lagu ilaaliyo sharciga. Isbitaalka iyo xubnaha shaqaalaha xirfadlayaasha waxay helayaan waxbarasho iyo tababar (si waafaqsan xrrka iyo shuruudaha sharciga) ee qiimaynta bukaanada soo bandhiga dabeecadaha laga yaabo inay joojiyaan awooda bukaanka inuu naftiisa iyo kuwa kaleba ka ilaaliyo waxyeelo ama dhaawac.

##### **Dookhashada dadka kusoo booqanaya**

Iyadoo la raacayo xeerarka isbitaalka iyo rugaha caafimaadka, waxaad xaq u leedahay inaad qaabisho martida aad dooratay inau kusoo booqdaan. Booqdayaashan waxaa ku jira, laakiin aan ku xaddidnayn, lamaanahaaga, qof guriga kugula nool (oo ay ku jiraan dadka isku guriga ah ee isku jinsiga ah), xubin kale oo qoyska ah, ama saaxiib. Martida kusoo booqanaysa lama xaddidi doono ama si kale looguma diidi doono mudnaanta booqashooyinka sababta oo ah isir, midab, wadanka asal ahaan kasoo jeedo, jinsi, nooca galmada, aqoonsiga jinsiga ama muuqaalka, da'da, ama naafanimada. Waxaad xaq u leedahay inaad ka noqoto ama diido ogolaanshahaas wakhti kasta.

Waxa kale oo aad xaq u leedahay in xubin qoyska kamid ah ama wakiil aad doorato iyo dhakhtarkaaga daryeelka aasaasiga ah si dhakhsiya ah la ogeysiyo dhigitaanka isbitaal ee bukaan-jifnimo.

##### **Si aad u hesho daryeel caafimaad oo ka jawaabaya baahiyahaaga gaarka ah**

Waxaad xaq u leedahay inaad hesho adeegyo, daawaynta ama hoyga laga heli karo xarumahayaga kuwaas caafimaad ahaan muhiim ah. Hadafkayagu waa inaan iswaafajino caafimaadkaaga shakhsi ahaaneed iyo hadafyada nolosha oo aan ku xisaabtano dhamaan q qofka aad tahay. Sida waafaqsan xeerarka cusbitaalka ee khuseeya, bukaanada naafada ahi waxay xaq u leeyihiin inay magacaabaan ugu yaraan sadex qof oo taageero, oo ay ku jiraan ugu yaraan hal qof oo taageero ah si uu u joogo wakhti kasta waaxda xaaladaha degdegga ah iyo/ama mudada lagu jiro joogitaanka

### **Si aad ugala hadasho oo aad uga qaybgasho go'aamada daryeelka caafimaadkaaga**

Waxaad xaq u leedahay inaad ka hadasho, su'aalo ka waydiiso, oo aad gaarto go'aamo khuseeya daryeelkaaga. Adiga ayaa si fiican u yaqaana naftaada, waana sababta aan u dhageysano hadafkaaga caafimaad oo aan kula wadaagno si aan u gaarno hadafyadaas. Waxaad xaq u leedahay in la ixtiraamo qiyamkaaga shakhsi ahaaneed, dhaqan ahaaneed iyo ruux ahaaneed, waxyaabaha aad door bidayso iyo waxa aad aaminsan tahay marka la go'aaminayo daawaynta. Haddii aad rabto, go'aamiyaha go'aanadaada ee aad aaminsantahay ama dad kale ee aad dooratay ayaa laga yaabaa inay ka qaybqaataan go'aamada ku saabsan daryeelkaaga. Waxaad sidoo kale xaq u leedahay inaad codsato latalin khabiir, akhlaaq-yaqaan iyo/ama wadaad diimeed. Iyo, inay kaaga caawiyaan hubinta inaad fahamto daryeelka lagu siinayo ama la soo jeediyay, adeegyada turjubaanka ayaa lagu heli karaa si lacag la'aan ah.

### **Si doonitaankaaga loo sharfo**

Waxaad xaq u leedahay in la ixtiraamo go'aamada daawayn ahaaneed. Haddii aadan awoodin inaad adigu iskaa u hadasho markaad go'aan ka gaarayso daryeelkaaga, waxaanu ixtiraami doonaa go'aamada qofka aad u magacawday awooda qareenkaaga ee daryeelka caafimaadka, wakiilka daryeelka caafimaadka, ama go'aanqaade aad aaminsan tahay. Haddii dardaaranada hore ama dhukumeenti kale oo qorshaynta daryeelka hore ay tilmaamayaan doorbidyada ku saabsan daawaynta gaarka ah, waxaanu ku ixtiraami doonaa doorashadaada inta xaddidan ee ay soo rogtay xaaladaada. Haddii aadan samaynin dardaaran hormaris ah ama dukumeenti qorsheynta daryeelka hore oo la mid ah, waxaan ku siin doonaa inaan kaa caawino buuxinta mid. Prov-dence waxay ku foogan tahay daryeelka ilaa dhamaadka noloshu ee buuxinta baahiyaha bukaanada iyo dadkooda ay jecel yihiin, dhimitaanka dhibaataadooda, iyo hormarinta heerka noloshooda. Waxaan bixin doonaa helitaanka daryeelka ruuxiga ah, daryeelka qandha-jabinta iyo daryeelka guriga dhexdiisa oo ah daryeel dhamaystiran oo joogto ah. Marka ay munaasib tahay, waxaanu kaa caawin doonaa maamulitaanka deeqaha xubnaha iyo unugyad kale si waafaqsan awaamiirtaada anagoo bixinayna daryeelka noloshada oo dhan oo naxariis leh.

### **Si loo helo ogolaanshaha iyo diidmada daryeelka**

Waxaad xaq u leedahay in dhakhtarkaagu kuusoo wargaliyo cudurada laga helay baaritaanada, daawayntaada iyo waxa sababay cudurkaaga hab aad fahantay, si aad u gaadho go'aamo xog ogaal ah oo ku saabsan daryeelkaaga. Ilaa inta ay suurto gal tahay, tani waa in ay ku salaysnaato sharaxaadda xaaladdaada iyo dhammaan habraacyada iyo daawaynta la soo jeediyay, oo ay ku jiraan suurto galnimada khatar kasta oo halis ah ama waxyeelooyin ah, dhibaatooyinka la xiriiir soo kabashada iyo suurto galnimada ka guulgaarista. Intaa waxaa dheer, waxaad xaq u leedahay inaad fahamto halista iyo faa'iidooyinka ay leedahay inaad helin hababka iyo daawaynta la soo jeediyay. Xaq aad u leedahay inaad hesho daawayn kuma xirna inaad haysato dardaaran hore, POLST, ama ka noqoshada amar ama joojinta taageerada noloshu sida amarka dib usoo celinta qof la suuxiyay. Bukaan iyo dadka loo xilsaaray waxay xaq u leeyihiin, inta ugu badan ee suurto gal ah, inay ka qaybqaataan go'aamada khuseeya daryeelkooda caafimaad, oo ay ku jiraan mashruuc kasta oo cilmi-baaris ah ama arrimo anshaxeed oo soo bixi kara.

isbitaalka. Midan waxa ku jira xaq aad u leedahay in aad diido daawaynta ama aad ka baxdo cusbitaalka, xataa haddii uu kugula taliyo in aanu sidaa samayn sababo caafimaad dartood.

### **Sii waditaanka daryeelka**

Waxaad xaq u leedahay inaad hesho macluumaad kuu ogolaanaya inaad fahanto ikhtiyaarada aad haysato marka aanu kaa caawino qorshaynta baahiyaha daryeelka caafimaad joogtada ah markaad ka tagto daryeelkayaga iyo xarumahayada. Tan waxaa ku jira maamulitaanka; daawaynta, qiimaynta, iyo haddii loo baahdo, u wareejinta xarun kale.

### **In si kuhaboon loo xakameeyo xanunn**

Waxaad xaq u leedahay in xanuunkaaga la xakameeyo mudada aad ku jirta qaadashada daryeelka iyo adeegyada.

### **Si aad ugala xiriiro daryeelka**

Waxaa lagugu dhiirigelinayaa inaad barato oo aad su'aalo ka waydiiso daawaynta aad qaadanayso. Haddii loo baahdo, shaqaalahayagu waxay ku heli doonaan turjumaan lacag la'aan ama waxay ku siin doonaan habab kale oo aad si buuxda ugu fahmi karto daryeelka lagugu siinayo ama laguu soo jeediyay. Ilaa aad noo sheegto in aanan ogaysiin, waxaanu sii wadaynaa xaq aanu u leenahay inaan ku ogaysiin karno dhakhtarkaaga aasaasiga ah, kooxda daryeelkaaga caafimaadka/dadka ama kooxda kale ee daryeelkaaga caafimaadka/dadka, iyo sidoo kale dhammaan adeeg bixiyayaasha daryeel ee xaalada degdega ah kadib iyo kuwa saadka bixiya isbitaal dhigistaada, saaritaankaaga, ama u wareejinta isbitaal kale. Markaad codsasto, waxaanu ogaysiin doonaa xubinta qoyska doorashadaada isbitaal dhigis ahaaneed, ka saaristaanka isbitaala, ama ka wareejinta isbitaalkayaga.

### **Diiwaanadaada caafimaadka**

Waxaad xaq u leedahay inaad hesho macluumaadka ku saabsan xaaladdaada caafimaad, waxyaabaha laga helay baaritaankaaga, waxyaabaha sababa cudurkaaga, nooca daawayn ahaaneed, rajada laga qabo soo kabashada iyo natiijooyinka daryeelka hab aad fahmi karto. Waxaad xaq u leedahay inaad hesho diiwaanadaada caafimaadka. Waxaad heli doontaa Ogeysiis gaar ah oo ku saabsan Hab-dhaqanada Asturnaanta kaas oo sharxaya xuquuqda aad u leedahay inaad hesho diiwaanadaada. Waxaad xaq u leedahay inaad hesho xiriiir wax ku ool ah iyo inaad ka qaybqaadato horumarinta iyo hirgelinta qorshahaaga daryeel.

Waxaad xaq u leedahay inaad ka qaybqaadato su'aalaha anshax ahaaneed ee soo kordho inta lagu jiro daryeelkaaga, oo ay ku jiraan arimaha xalinta khilaafaadka, joojinta adeegyada suuxinta iyo ka noqoshada ama ka noqoshada daawaynta noloshu badbaadiya. Intaa waxaa dheer, waxaad xaq u leedahay inaad iska diiwaangeliso websaytka bukaan ee MyChart. MyChart waxay bixisa macluumaad cusub oo ku saabsan balamaha, daawooyinka, xaaladaha caafimaadka, shaybaarada, daraasadaha, soo koobida booqashada kadib, qoraalada caafimaadka iyo macluumaadka kale wakhtiga dhabta ah iyada oo aan lahayn codsi gaar ah. Fadlan booqo Providence.org wixii macluumaad dheeraad.

## **Asturnaanta iyo qarsoodi ahaanta**

Waxaad xaq u leedahay daawaynta qarsoodi ah ee dhamaan xiriirada isgaarsiin ahaaneed iyo diiwaannada khuseeya daryeelkaaga iyo joogitaankaaga isbitaalka. Waxaad heli doontaa Ogeysiis Gaar ah ee Hab-dhaqanada Asturnaanta kaas oo si faahfaahsan u sharaxaya xuquuqahaaga gaar ahaaneed iyo sida aan u isticmaali karno oo aan u shaacin karno macluumaadkaaga caafimaad. Waxaad xaq u leedahay in asturnaantaada shakhsi ahaaneed la xushmeeyo. Ka wadhadalka xaalada, la tashiga, baaritaanka, iyo daaweyntu waa kuwa qarsoon waana in loo sameeyaa si qarsoodi ah. Waxaad xaq u leedahay inaad ogaato magaca dhakhtarka haysta kaas oo ku shaqaynaya baaxaada doorka xirfadeeda ama xirfadiisa ruqsad ahaaneed kaas oo leh mas'uuliyadda aasaasiga ah ee maamulitaanka daryeelka, magacyada iyo xiriirka xirfadeed ee dhakhaatiirta iyo kuwa aan dhakhaatiirta ahayn ee arki doona bukaanka iyo in loo sheego sababta joogitaanka qof kasta.

## **Si aad cabasho uga sheegto daryeelkaaga oo aad nooga hesho jawaab**

Waxaad xaq u leedahay inaad ka hadasho cabashooyinka ku saabsan daryeelkaaga iyo inaad naga hesho jawaab, adoon saamaynayn tayada ama bixinta daryeelkaaga. Waxaad soo wargalin kartaa ama la xiriir kartaa mid kamid ah wakaaladaha hogaaminta ee hoos ku qoran. Macluumaad xiriir ahaaneed oo

dheeri ah oo lagala xiriiro cabashada iyo warbixinta cabashada ayaa laga heli karaa xarunta daryeelka caafimaadka aad doorato ama xarunta daryeelkaaga caafimaadka.

## **Si aad u fahamto mas'uuliyaddaada dhaqaale iyo ikhtiyaarrada kaalmo ahaaneed**

Bukaankeena ahaan, waxaad codsan kartaa qiyaasta kharashka waxaadna xaq u leedahay inaad hesho nuqulka biilka oo si fiican u qeexan oo la fahmi karo. Marka la codsado, waxa kale oo lagu sharixi karaa kharaska. Haddii ay ku haysato dhibaato dhaqaale, fadlan kala xiriir xaruntayada adeega macaamiisha 1-866-747-2455. Waxaad ka heli kartaa waxyaabaha ku saabsan ikhtiyaarada lacag bixinta ama haddii aad u qalanto kaalmada maaliyadeed, iyadoon loo tixgalinin caymiska aad haysato. Waxaa naga go'an inaan la shaqeyno bukaannadayada oo dhaan kuwaas oo codsada caawinta bixinta biilka caafimaadka.

## **Si aad u hesho macluumaadka xeerarka xarunta daryeelka**

Haddii aad codsato, waxaad heli doontaa macluumaadka ku saabsan xeerarkayaga, qawaaniintayada ama shuruucdayada khuseeya daryeelkaaga, oo ay ku jiraan isticmaalka xoolaha adeega ee goobaha dadweynaha ee ku dhex yaala xarumaha daryeelka, iyadoo lagu salaynayo sharciga federaalka.

## **BUKAAN AHAAN, XUBIN QOYS AHAAN, AMA BOOQDE AHAAN AAD WAXAA MASUULIYAD KUGU AH:**

Providence St. Joseph Health and its affiliates waa goob daryeel caafimaad, halkaas oo daryeel bixiyayaasha, bukaanada, xubnaha qoyska iyo booqdayaasha ay tahay inay dareemaan soo dhaweyn, badqabka, iyo ixtiraam. Waxaan ka codsanaynaa oo aan ka rajeyneynaa dhamaan dadka noo imaada ama noosoo raadsada daryeelka inay ula dhaqmaan iyadoo ixtiraamayo qof walba sharaftiisa, oo naga caawiya inaan bixino daryeel naxariis leh oo tayo sare leh. Xubnaha shaqaalaha waxa lagu doortaa xirfadooda iyo khibradooda badqabkoodu waa muhiim. Dhibaataaynta ama si xun ula dhaqmida shaqaalahayaga looma dulqaadan doono. Inta aan ku jirto daryeel bixintayada ama aad soo booqanaya qof daryeel ku qaadanaya xaruntayada, waxaan kaa fileynaa waxyaabah soo socda:

- Inaad tixgaliso oo ixtiraam kuwa kaa ag dhaw, oo ay ku jiraan kuwa bixiya daryeelka ama qaadanaya daryeel.
- Faham in daryeel bixiyayaasha aan dib loogu meelayn doonin sababo aan la xiriirin doorkooda xirfadeed.
- Ka fogow isticmaalka midabtakoorka iyo/ama luuqad af-xumo ah ama dhaqankeeda noocuu doono ha ahaatee. Looma dulqaadan doono oo waxay keeni kartaa ka bixitaanka ama ka saarida xarunta.
- U sheeg daryeel bixiyahaaga waxyaabaha ku saabsan mudnaanta caafimaadkaaga, si aad si wadajir ah u samaysaan qorshe.
- U sii taariikhdaada caafimaad ahaaneed iyo macluumaadka daawaynta si sax ah oo dhamaystiran.
- Soo wargali isbeddelada lama filaanka ah ee ku dhaca xaaladdaada, ka qayb qaado go'aaminta go'aamada, oo su'aalo ka weydii daryeel bixiyayaasha ku saabsan daryeelkaaga.
- Tixgeli talada daryeel bixiyayaashaada oo raac qorshaha daawaynta ee lagugula taliyey. Midan waxaa kamid ah ogeysiinta daryeel bixiyayaashaada haddii aadan awoodin inaad ilaaliso balan ama aad raacdo amar caafimaad oo lagu faray.
- Na sii nuqulka dardaaranka caafimaadkaaga, dardaaranka noloshu iyo/ama aqoonsiga iyo macluumaadka xiriirka ee dadka aad dooratay ee aad aaminsan tahay ee gaari kara go'aanka, haddii aad mid leedahay.
- Kala shaqee daryeel bixiyahaaga si aad u buuxiso dardaaranka caafimaadka, haddii aadan mid lahayn.
- Faham mas'uuliyadahaaga maaliyadeed iyo ikhtiyaarada kaalmada maaliyadeed.
- Raac xeerarka xarunta daryeelka.
- Kusoo dhaaf dhamaan alaabtaada shakhsi ahaaneed guriga.

## **XUQUUQDA DHEERAADKA AH EE GOBOLKA OREGON:**

Haddii qof naafo ah u yimaado Providence daryeel caafimaad, waxay yeelan doonaan xuquuqaha soo socda:

- Inay doortaan ugu yaraan saddex qof taageera u ah oo iyaga ka caawiya xiriirka iyo go'aan ka gaarista daryeelkooda haddii ay qabaan naafo jireed, maskaxeed, dabeecad, ama garasho, dhego la'aan, maqal la'aan ama caqabado kale oo isgaarsiineed, indho la'aan, autism ama waallida. Qofka taageerada ah wuxuu noqon karaa xubin qoyska ka mid ah/qof kale oo muhiim ah, mas'uul, kaaliyaha daryeelka shakhsi ahaaneed ama kaaliyaha kale oo mushahar leh ama aan mushahar lahayn oo uu doortay bukaanku. Ugu yaraan hal qof oo taageere ah ayaa laga yaabaa in uu sariirta dhinaceeda la joogo bukaanku mar walba isbitaalka, oo ay ku jirto qolka gargaarka degdegga ah.
- Si aad u hesho qof taageere jir ahaan u jooga wadahal kasta oo ku saabsan daryeelka hospice, saxeexa dardaaran horumarsan, ama samaynta go'aamo macnaheedu noqon karo joojinta daawaynta nolosha qofka ku reebeyso, ilaa bukaanku si kale u codsado. Providence ma shuruudayn doono in daawaynta la siiyo bukaanka qaba POLST, dardaaran horumarsan, ama amarka ka noqoshada ama ka joojinta taageerada nolosha, sida amarka Dib Ha U Soo Noolayn.
- Haddii codsiga bukaanku in qof taageero ah uu joogo sariirtiisa dhinaceeda uu xaddido ama diido isbitaalku, waxaa isla markiiba la ogeysiiyaa fursadda ay ku codsan karaan shirka daryeelka taageerada si looga hadlo diidmada iyo cabbir kasta oo loogu oggolaado qofka taageerada ah inuu joogo. Shirkan taageerada waxa loo muddayn doonaa sida ugu dhaqsaha badan, laakiin kama dambayn doono 24 saacadood ka dib jiifitaanka ama ka hor habraaca ama hawlgalka.
