Training on Electronic Prescribing for Controlled Substances (EPCS) for EPIC

Anyone who prescribes DEA controlled substances is strongly encouraged to sign up for EPCS for EPIC during this time. If you are currently enrolled for EPCS in Meditech, unfortunately it will NOT roll over and you will need to enroll again. An enrollment process for all qualified IP Providers began in April and continues through the Epic Go-live.

EPCS allows providers to transmit prescriptions of controlled substances directly to retail pharmacies from Epic. EPCS compliance consists of a two-factor authentication process when ordering a controlled Rx. It is supported with at least two of the following security modalities:

- Fingerprint (using a biometrics reader connected to the network computers)
- Password
- Soft Token (notification via the providers Smartphone).

The EPCS the enrollment process takes 10 to 15 minutes per provider, with a briefing on two-factor authentication and the workflow process. You will need your valid ID: driver's license and Providence ID, and need to know your phone password (to download the Imprivata application from the App store).

EPIC is set to launch on May 15. Anyone who hasn't finished training will not have access to the new EMR! Have questions? Please email SJHproviderengagement@providence.org

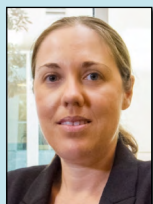

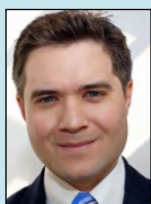
