# Providence Portland Medical Center and communities



In 2023, Providence Oregon continued its tradition of compassion and dedication to our communities, with Providence Portland Medical Center investing more than \$94.7 million to improve community health. These targeted investments included \$6.5 million in community health services and \$11.1 million in free and low-cost care.

#### PROVIDENCE INVESTS IN OREGON'S HEALTH

### SUPPORTING MENTAL WELLNESS IN THE LATINX COMMUNITY

Providence funding helped Raices de Bienestar expand its culturally specific mental health counseling program and community engagement efforts. As a community-based program working to improve the emotional health of Latinx people, Raices de Bienestar increased the number of people they could serve with services such as individual therapy. They also offered community activities that attracted nearly 2,000 individuals in 2023.

## EXPANDING SUPPORT FOR DISABLED IMMIGRANTS AND REFUGEES

With funding from Providence, the Immigrant and Refugee Community Organization (IRCO) was able to expand its Disability Legal Services (DLS) program. The DLS program helped immigrants and refugees with disabilities obtain Social Security Income and Social Security Disability Income benefits. More than 90% of IRCO clients successfully obtained benefits, thus directly improving economic security for these individuals and families.

### PROVIDING MENTAL HEALTH SUPPORT AND WORKFORCE TRAINING


In 2023, Providence helped support the efforts of Serendipity Center, an organization for creating greater access to therapeutic education for students suffering from mental illness and trauma. The program focused on workforce development for students by generating on-site workforce training opportunities, creating partnerships with business and employment agencies, and improving programs for transitioning work and life skills.
